DECLARATION

I am at least 18 years old and would like to participate in the "50/50" event which will be held on 20 to 27 August 2022 in and around the Tarentaise Region, Savoie, France. I irrevocably and unconditionally accept the conditions below, both for myself and for my heirs, successors, assigns, assigns and insurers:

RECOGNITION OF RISKS.
